Call to Order

Nan Carmack called the meeting to order at 10:03 a.m.

Secretary's Report

Rebecca Purdy directed attention to the draft minutes from the April 19, 2024 Council meeting which were posted on the VLA website. Quettara Drayton moved to approve the minutes as presented; Jennifer Scott Brown seconded. The motion passed.

Treasurer's Report

Maryke Barber announced that forty-one libraries have signed up for the Amazon Business program thus far and that 25,000 books will be available for discount in the future. Lisa Varga shared that Amazon Business will present a poster session at the upcoming VLA Conference in addition to having a table in the vendor hall.

Maryke presented the written 2024 Statement of Activities. She informed the Council that affiliate and institutional memberships are very close to the targeted amount and that jobline is doing great. The investments will be updated at the next meeting as those are quarterly reports.

VLA Chapter Councilor to ALA Report

Kerri Copus shared that the ALA Conference will be held before the Council meets next and there will be more to report at the September Council meeting. One resolution that will be considered at the upcoming American Library Association meeting is the draft ALA Councilor's Resolution to Support AASL School Library Chapters and ACRL Academic Library Chapters.

Legislative Update

Lisa Varga reported that state aid for libraries has increased by 2.5 million dollars for FY25.

Executive Committee Report

Nan Carmack announced that the Executive Committee has been working on a Position Statement Framework. Keith Weimer shared that the Intellectual Freedom Committee used the draft framework for a recent statement made by the Committee and found it helpful. Nan shared that the Executive Committee had voted yesterday to make minor changes: change the document name from Societal to Position, adding to the Position Statement Elements section that any statement will include appropriate contact information within the statement and extending the response timeline to 72 hours. Quettara Drayton moved to approve the Position Statement Framework, Keith Weimer seconded. The motion passed.

Nan Carmack shared that the Dignity Index will present an online webinar on September 23, 2024 at 4 p.m.

VLA Annual Conference

Natasha Payne-Brunson shared that the deadline for presenters to accept their presentation dates and times for the upcoming conference has passed and that there is still space for a few poster sessions. Nan Carmack encouraged attendees to bring their creativity as there will be ample opportunities to use it. Lisa shared that there will not be an awards banquet this year and award honorees will be recognized in a new way.

2025 VLA Election – Candidate Statements

Kimberly Knight thanked Kendra Hawkins for chairing the nominating committee and recognized Lisa Broughman for her assistance in identifying candidates.

The candidate for secretary Kendra Hawkins and candidates for vice-president/president-elect Dorothy Hargett and Nancy Falciani-White gave brief statements on their experience and interest in the position. Candidate for secretary, Reagen Thalacker, was unable to attend.

Lisa Varga shared that elections will open on August 1 and that VLA members who have joined before July 1 will receive ballots.
