Keith Weimer moved the minutes be approved. Jessica Scalph seconded, and the motion carried. Jennifer passed around a roster for attendance.

Treasurer's Report

The report for June is available on the website. Overall the accounts are in good shape. Our expenses are less than our income, which is always good!

The membership revenues from the Institutional, individual, and organizational membership are still below what was budgeted for the year

JobLine revenue is on track for the year with \$6,800

The budget reflects the final numbers for the events we had in April/May. Looking at the total expenses/revenue for the programs each was able to make a small profit.

The investment numbers are the ones from the end of April, as we have not received the May report yet. They are still on a bit of a downswing, but not too concerning.

Four Spring events complete: VLACRL Spring Program, The Innovative Library Classroom, VLA Professional Associates Conference and Virginia Library Leadership Academy.

Joint Conference of Librarians of Color Travel Grants: 2 winners selected from a pool of 14 applicants. Thank you to the committee: Todd Elliott (VLA President) Julius Jefferson (Library of Congress) and Eva Poole (Virginia Beach Public Library Director) and Rose Dawson (Director, Alexandria Library) for their service to VLA. All applicants have received notice. Lisa is working with all applicants to start a new Committee/Forum for VLA that meets the needs of Librarians of Color.

VLA logo updated as well as VLA website. Logo Committee is in process.

American Libraries Online article published May 4. Co-authored with Kelly Miller, Coordinator of Library Services for Virginia Beach City Public Schools and Past President of the Virginia Association of School Librarians: Finding Advocacy Allies: Library associations in Virginia team up to fight bad bills https://americanlibrariesmagazine.org/2018/05/04/finding-advocacyallies/

National Library Legislative Day: more than 30 Virginians participated; we met with staff from both Senators Kaine and Warner and many congressional staff. Special thanks to Renee DiPilato

for making everything happen. VLA spent \$3,911 reimbursing attendees for going to DC. Special thanks also to the Library of Virginia for creating the Library Services and Technology Act Infographic that we distributed to VA legislators. The info graphic may be viewed here: https://www.vla.org/assets/infoLSTA%201.pdf Meeting with Dave Brat went especially well; he came out and met our group and took a photo. Chuck Wray of BCWH Architects joined us. Chuck has been building libraries for about 10 years. He started talking in the meetings about how when you build a library property values increase in a certain radius. He spoke about how he had seen small businesses start out of libraries. These statements coming from him seemed to resonate more with the staff we met with. Eva Poole and Lisa Varga will meet with Scott Taylor's people in Virginia Beach next week to talk about how libraries aid Workforce Development. We borrowed an idea from the Indiana Library Federation where we used purple file folders that said LIBRARIES on the tab. Inside the folder was the infographic, 2 sheets of information from ALA, and Lisa's business card taped in it. Each person they visited got one.

ALA Policy Corps: Lisa stayed an extra day in Washington for more training with the Policy Corps. This focused on improve and media training, and then discussion of our next steps.

ALA Annual Conference: Lisa is helping at Chapter Leader's Forum; attending the State Ecosystem Initiative, will talk about Policy Corps at Chapter Relations Committee. Presenting with the Washington Office on Saturday. Volunteering with Resume Review Service, attending International Council of Library Association Executives meetings and presenting on Policy Corps there as well.

Todd stated that Lisa is doing a fantastic job as Executive Director. The Council applauded in agreement.

Executive Committee

Todd gave the Executive Committee Report. Todd discussed the monthly newsletter. He asked if there is anything that Council would like to see in the monthly newsletters. Email anything you would like to see in the newsletter to Todd or Lisa Varga.

We discussed the VLA Code of Conduct. Dorinne Banks, chair of VLACRL, made the recommendation for the VLA Code of Conduct. The Executive Committee made edits to it and returned it to Dorinne for her feedback. Dorinne's only recommendation was to remove the acknowledgements at the end of the statement. The wording may be viewed below under Other Business.

We also discussed the ALA Councilor position. The position is a member of Executive Committee, but it is a non-voting member. We are not sure why this position was made a non-voting member of Executive Committee. This is an elected position. We would like to make this position a voting member. Barbara Ferrara made a motion to make the ALA Councilor a voting member of Executive Committee. Seconded by Gregg Grunow. Motion carried.

Teresa Doherty raised the question of who are considered voting members on the VLA Council. She was filling in for the chair of the Intellectual Freedom Committee and wondered if she could vote. Keith indicated that voting is not explicitly mentioned in any one position except for the

ALA Councilor. There may need to be a change to the By-Laws saying who can vote and who can bring motions at Council. During this discussion it was discovered that the ALA Councilor is not listed as a member of the Executive Committee in the manual. Jessica Scalph was ALA Councilor when the position was added to the Executive Committee. She remembers that it was voted on and passed by VLA Council. This happened when Matt Todd was president. For some reason it was not changed in the manual. Jennifer will find when ALA Councilor was made a member of Executive Committee.

Todd reported on the VLA Disaster Relief Fund. He reached out to Lisa O'Donnell from the Florida Library Association. The Texas Library Association has a very clear path for their disaster relief funding. He is currently putting together all the information he has gathered thus far.

Legislative Update

Phil Abraham reported. He thanked Council for allowing him to serve VLA. This year we had to find a new House champion. There was also lots of turnover on the House Appropriations Committee. There were 5 new committee chairs, including the chair over the Library of Virginia. Delegate Nick Rush of Christiansburg (chairman of the Higher Education Subcommittee) agreed to put in our budget amendment for a \$2.5 million increase in state aid. Delegate Mark Sickles from Fairfax County the ranking Democrat on that subcommittee also agree to put in the amendment. Senator Tommy Norment of Williamsburg put that same amendment in on the Senate side. The Senate agreed to increase state aid by \$250,000 in the first year, \$500,000 in the second year. The House included no new money for state aid. They kept in there \$500,000 a year for a capital project that the Eastern Shore Library. When the budget was passed it included the state aid proposed by the Senate and the money for the Eastern Shore Library. We really did well this legislative year. We worked on two bills this session. Phil was very pleased with the way everything went during this legislative session.

Todd thanked Phil for all his hard work on behalf of VLA and the Council echoed that thanks with applause.

VLA Professional Associates Conference

Jeanne Scott reported on the VLAPAF Conference. The VLA PAF 2018 Conference "Other duties as assigned", was held that the Marriott at City Center in Newport News on Monday, May 21. The final count of registered attendees was 178, up from last year's total of 158, an increase of about 13.

Each attendee received an email evaluation form. We got 90 responses, about half of our attendees. This was somewhat disappointing, but we did receive some great feedback, suggestions for our next conference and a lot of interest in becoming more involved by joining the VLA PAF Board.

The overall results from the survey revealed that attendees liked the venue – easy to get to, nice facilities, decent food, really good air conditioning and free parking. Our keynote speaker, Mauricio Velasquez, spoke on "Toxic employees – Toxic workplaces." He was well received

and the topic hit home for many of our attendees. Tips on how to deal with toxic employees and other folks you encounter who fit this description were welcomed.

One disappointment for our attendees were some last minute cancellations by a few presenters. The topics of the many remaining sessions were very diverse, geared to everything from Academic Libraries to Youth Service. Areas that were addressed covered career development, how to assist users in recognizing fake news, and learning "How can I not help you?" (our most popular session). There was also a round of lightning talks that touched on many different topics, which was also very well received. We hope to be able to offer more sessions of this nature at our next conference.

The board was concerned about the lack of networking opportunities, but most of the attendees were able to make new connections throughout the day. At lunchtime, the tables were labeled with various topics in order to help with networking. This was somewhat successful, but there is still work to be done. We feel the need to promote networking to our fellow professional associates so they understand the value of it – why it is so important, and how to do it successfully. We work on offering a session specifically on networking at our next conference.

The VLA PAF Board is looking forward to our next conference. One of our goals will be to secure a more central location for the next forum. We feel that a more central location will enable those in the farther reaches of the state to attend more easily, as the number of attendees from the western part of the state has declined considerably over the last few years. Keeping the conference focused on professional development, how associates can be better at what they do and how they can work to advance themselves in their chosen careers is a must.

They have been discussing having the conference every other year for two days. The VLAPAF conference would be in odd years while the VA Library Leadership Academy (VALLA) would be in even years. They also want to be more intentional in the programing they are offering. Lisa Varga discussed spending 2019 and 2020 doing half-year focus groups and regional meetings to figure out what people want out of a conference. The VLAPAF conference would then return in 2021. Lisa also invited Jeanne to join the 2019 VLA Annual Conference committee to see how they plan and facilitate that conference.

Adrian asked if VLAPAF has a co-chair yet. Jeanne reported that they have not met since the conference to discuss that. Adrian also asked Jeanne to email him her contact information so that he can update it on the website.

VLA Annual Conference

Lisa Varga reported on the VLA Annual Conference. The conference is September 26-28, 2018 at the Colonial Williamsburg Lodge. They are hoping to open registration in the next week or so. However, they are not sure if this will happen or not because their designer is currently on vacation.

There will be no early bird registration this year. There will be advanced and late registration only. Having only two types of registration will make things easier.

There will be fewer subject headings this year. VLACRL will have special indication since the proposals are peer-reviewed. In the conference program there will be a letter from Clint explaining some of these changes. They are adding different learning styles and types of sessions (i.e. workshops).

There will be an introvert lounge and an extrovert lounge. This idea came from Teresa Doherty.

The social will be 1980s themed. There will be trivia from Urban Librarians Unite at the social.

They are working on changing the Friday lunch option. They are planning bingo and some educational programming. They are hoping to get it paid in part by the vendors. Still have to see if the vendors will agree to this.

They have some creative sponsorship opportunities. One is an option to name the WiFi.

The exhibit hall is smaller this year. It holds 65 booths compared to the 83 we had last year. registration opened for vendors a few months ago. There are currently only 4 spaces left.

ALA Councilor's Report No report

<u>Association of College Research Libraries (VLACRL) Forum</u> (report submitted by Dorinne Banks)

VLACRL offers two, free professional development programs each summer. This year's Summer Programs will be on the topic of "Library & Campus Partnerships for Student Success". Hosting libraries will be <u>Virginia Wesleyan University</u> and <u>University of Virginia</u>. Dates and more details will be announced soon.

We will have one officer opening (co-chair), to be filled in Sept. 2018. Elections will be held electronically prior to the VLA conference. Co-chair is a 3-year commitment, rotating from co-chair, to chair, to past chair. If you (or someone you know) are interested in learning more about what is involved, contact one of our current officers.

Our dinner meet-up at the 2018 VLA Conference will be held at 6:30 on Thursday, Sept. 27th. We are in the process of selecting a venue. Sign-ups will be available closer to the time of the conference.

Jennifer Resor-Whicker reported on this year's The Innovative Library Classroom conference. There were 100 attendees from 11 states. TILC 2019 will be at William & Mary.

Awards and Recognition Committee

Tina McPherson reported. There was a small number of nominations this year. The committee is going to discuss how to get a higher turnout for the next award season. Discussion ensued about how to get more nominations. It was suggested that VLACRL work with the Awards and Recognition Committee to promote the Academic Innovator Award. It might be a good idea for certain forums/committees to advertise certain awards. Tina said that she would work on ideas on how to get more nominations to present to the Council in September.

<u>Collection and Technical Services Forum</u> (CaTS) (report submitted by Liz Steyer) Collections and Technical Services (CaTS) had another successful Collection Management Forum in May at the Varina Library. Thanks to everyone who attended!

We are exploring options for a virtual meeting, discussion and/or webinar for the summer and are also looking forward to the VLA Conference.

We encourage all VLA members to sign up for the CaTS e-list on VLA.org so that users can get up to date news about what's happening. It's also a great place to post questions about Tech Services, technology, cataloging, collections and more!

<u>Continuing Education Committee</u> (report submitted by Barbara Ferrara)

Barbara Ferrara reported. The Continuing Education Committee (CEC) did not meet this quarter, however two subcommittees have been formed: one to work with the Continuing Education Consultant at the Library of Virginia's Networking and Development Division to create a survey of professional development interests of librarians in Virginia. The other committee is charged with updating the CEC's part of the VLA website and to make a recommendation about the wiki and files related to VALLA and the defunct Leadership Development Forum.

The survey group has its first phone meeting scheduled June 18th. The website group met with our website committee liaison Natalie Hutchinson on April 19th. As a result, the Continuing Education Resources page and link have been removed and the Library of Virginia's Continuing Education page is now linked to the CEC page. Language has been added to clarify that the Leadership Development Forum has been merged with CEC and the VALLA page can be accessed from the CEC page. Clint and I are working to move the VALLA files from all the academies since 2010 to a Basecamp page and to set up a section for future incoming coordinators about the various steps and decisions that go into having an Academy.

VALLA was very successful. Clint did a great job and thought about everything and everyone. As we saw in the Treasurer's report, there was a profit. 27 people attended and surveys were sent out a few weeks after it was over. The feedback (about a 60% response rate) was overwhelmingly positive, with especially strong appreciation for Maureen's presentations and knowledge. Some did suggest making it two days and there were a couple of comments about thinking maybe a project should have followed. Those will help in the planning for the 2020 cohort. VLA put out a press release about it and I know Richmond Times Dispatch picked it up because Chesterfield attendees and their photos were published.

CEC is interested in facilitating a presentation academy for next Spring. Nathan Flinchum was one of the organizers the last two times they were held and they were well-received. We think the CEC is an appropriate group to do this because of our charge. Going forward, perhaps this is something that can be held on alternating years with VALLA. The previous format was about a ½ day in-person, then a couple of follow-up webinars and we would discuss updating it, but nothing that would be overnight. If preferred, we might also consider creating a presentation that we can take on the road to present (for a fee) at individual libraries.

Diversity and Inclusion Forum (report submitted by Maryska Connelly-Brown)

The 2017 VLA Graphic Novel Diversity Award winners have been selected and will be awarded at the annual conference in September. All ten judges for the 2018 Graphic Novel Diversity Award have been selected and assigned to either the youth or adult categories. A training packet will go out next week to the judges. Currently, letters are being sent to publishers inviting them to submit eligible graphic novels. We have yet to receive any submissions for 2018.

Intellectual Freedom Committee

Teresa Doherty reported. The IFC had a panel at the VLAPAF conference about patron challenges and banned book questions. Teresa also hosted the lightning talks at the VLAPAF conference. The IFC has a session coming up at the VLA Annual Conference call I Spy Intellectual Freedom Issues at Your Library. It will focus on library facilities and online spaces.

Jefferson Cup Committee

Cindy Church reported. Cindy discussed a new exhibition at the Library of VA called "Sons of Freedom." She passed out postcards advertising this. There is also an online component to this exhibition. The Library of VA is moving ahead with their booth at the State Fair thanks to VLA's support. The State Fair begins on September 28. They are looking for volunteers to staff the booth.

<u>Local History, Genealogy & Oral History Forum (report submitted by Stephanie Hardy)</u>
Stephanie Hardy reported. The Archivists and Washington and Lee University, Virginia Military Institute, and Southern Virginia University are planning a "Preserve your Family History" event to be held later this summer. This will be done in conjunction with the Paxton House, a local history site.

New Members Roundtable (report submitted by Lisa Becksford)

Lisa Becksford reported. Our mentoring program is going strong and will continue until October. We have two events planned for the conference – the pub crawl, and a panel discussion featuring middle managers or those who are newer to management. We are still looking for additional panelists. Also, we're hoping to run a meet a member feature leading up to the conference.

Scholarship Committee (report submitted by Michael Hibben)

Michael Hibben reported. The Scholarship Committee completed the selection process for the winners of the 2018 Scholarships. This year's winners include Melinda Manuel from the Roanoke County Public Library, who won the VLAPF Clara Stanley Scholarship. Chelsea Seddon (from the Roanoke City Public Library System) and Bonnie Shaw (from Earl Gregg Swem Library at the College of William & Mary) won the VLA Scholarships. The committee congratulates our 2018 winners!

The Scholarship Committee is also about to begin work on making recommendations on some changes to the eligibility for the scholarships and clarifying language on the website and application to make it clearer who is eligible to apply. We will submit those recommendations for changes to Executive council within the next month for review and possible approval.

We've also reached out the Website Content Committee to help us create a scholarship raffle basket idea generator that we could embed somewhere on the VLA website.

Teresa Doherty recommended removing gender from the application if it is there. She also suggested including Mx as a prefix along with Ms., Mr., Dr., etc. She also suggested including a space for pronouns. Michael did not recall any gender questions being on the application, but he said he would look into it.
